Capital Improvement Projects help ensure that we maintain enough capacity to meet water needs. Below is a partial list of the Capital Improvement Projects the District has planned for 2025.

Project Estimated Cost

Highway 63 Bore @ Eagle Knoll: Installation of 1,500 feet 8-inch water main including 560 feet bore crossing Highway 63 between South Mount Pleasant Road and Westbrook Drive. This project will create a redundant feed to the southern portion of the District.
